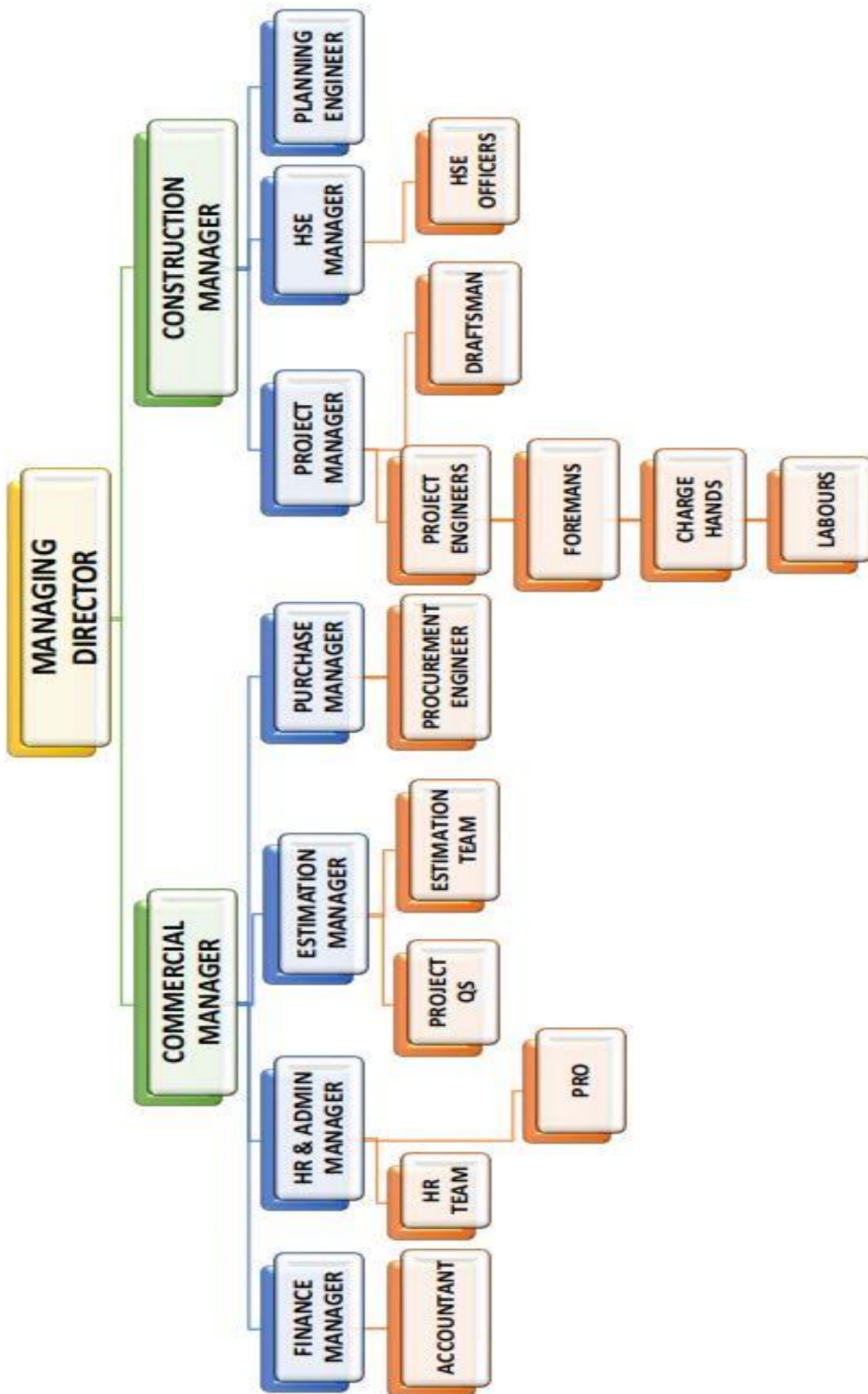

HEALTH, SAFETY AND ENVIRONMENT PLAN

STRUCTURE OF THE QUALITY SYSTEM

- Level 2 :Quality System Procedures, which describe the responsibilities and method to be followed for carrying out various activities and tasks in sufficient detail.
- Level 3 : Work Instructions, Forms, Quality Plans, Job Descriptions
- Level 4: National & International Standards.

The quality system has been implemented through the issue of the above documents in accordance with the company's documents control procedures.

Quality records are maintained in accordance with the procedures to provide evidence that the requirements of the quality system standard as well as client quality requirements are met.

QUALITY PLAN

VINSCON CONSTRUCTION LLC carries out quality planning, identification of resources requirements, training needs and master programme shall constitute part of quality planning.

Quality Plans will be prepared if contractually required.

Where required in the contract or decided by senior management, specific quality plans will be generated by the Contracts Manager in consultation with the Project Manager and other managers, as appropriated.

The contract quality plans will be included as a minimum requirement:

- Task
- Inspection Frequency
- Inspection Method
- Inspected By
- Report

Once developed and agreed with the client, these plans become the controlling documents for the contract and are subjected to audit and management review in accordance with our procedures.

DOCUMENT & DATA CONTROL

Document and data control relating to quality system has been established to ensure that

- All documents are reviewed and approved prior to issue
- The master set of applicable documents is maintained and updated
- Obsolete documents are promptly removed from all points of issue and use

The procedure ensures that the documents of external original essential for the company's quality system are adequately controlled.

QUALITY PLAN CONT...

PURCHASING

The company has established the approved vendor's list, and the mechanism for selection of new suppliers is in place.

Purchasing documents clearly and completely describe ordered products and the quality requirements.

Purchase documents are reviewed and approved prior to release.

No incoming material is used until approved by receiving inspection.

Purchasing at the correct time will help to avoid unwanted storage requirements.

VINSCON purchase team will help the client to get exactly what they have in their view.

By checking with many suppliers and vendors, we give the best materials at best price for the client.

In the event of any material supplied by the client / customer the material will be subject to the following controls:

- Check for correct identity and quality and that is free from damage
- Storage of materials in such a manner that degradation is minimized;
- In the event of any problem at any stage, the incident will be reported to the client and remedial action agreed;

INSPECTION & TESTING

Inspection and testing activities are carried out to verify that the specified requirements for the service are met.

Inspection and checking of all incoming materials is carried out to verify the compliance with the requirements. The procedures ensure that such products are not used until inspected. Provision has however been made enabling release of product for urgent needs prior to verification. Procedure however ensures positive identification of such product to enable immediate recall, should the product be non-conforming to specified requirements

QUALITY PLAN CONT...

CALIBRATIONS

All inspection, measuring and test equipment used demonstrating the conformity of the product is controlled and maintained in a known state of accuracy.

Such measuring and test equipment is subject to checking / calibration under suitable conditions

HANDLING, STORAGE & DELIVERY

The handling methods employed by the company are intended to prevent damage or deterioration to the products at all sites or while kept in the storage areas.

Designated storage areas are provided for incoming materials.

All subsequent movement of materials are controlled through the Application of established procedure and defined authority levels.

Transportation used for moving products shall be suitable for that purpose in order to protect products and minimize the risk of accidental damage during transit.

All delivery to and from site will be carried out by our transport or approved transportation.

Manual shifting of any materials are controlled under supervision. All shifting are carried out by small/heavy equipment's hired with professionals to avoid damages, time consumption, and any possible hazards.

All finishes materials are stored at covered, easily accessible storage spaces.

Full time site security available till the handing over of project to ensure any single theft or loss of material is not happening
